

Privacy Policy

Sonning Hockey Club (“SHC”) is committed to protecting your personal information and respecting data protection laws around the world. This privacy policy explains how we do this, and how it applies to your use of SHC websites, products, and services.

What information does Sonning Hockey Club collect?

We collect and process personal data about you when you register on to the website, interact with us and our websites and purchase products. This information includes:

- Your name, username, profile picture and password
- Your date of birth, ethnicity, residential address, email address, and phone number
- Your teams, associated statistics and any club role that you have
- Your medical conditions and hockey related qualifications
- A record of products which you have purchased

How we use your personal information

We use personal information as follows:

- To provide club news and updates if you ask for this
- Contacting you with information about fixtures and leagues
- Contacting you to enable you to set availability for games
- Managing teams and fixtures
- We also will supply to the relevant leagues and Fixtures Live such personal data that they require in order that you may participate in league activities. Data supplied to them is then subject to those bodies' privacy/data protection policy
- Storing your information for health and safety, child protection, welfare and England Hockey reporting purposes
- Storing statistical data for league competitions
- Providing you with access to membership and social products

Giving and withdrawing your consent, and updating your personal information

Where your consent is required for us to process your personal information, we will ask for your consent at the point at which you provide your data. You have the right to withdraw that consent at any time. You can also update your personal information at any time.

We do not sell your personal information to third parties.

Storing your personal information

Your personal information may be stored and processed outside of the country where it is collected, including outside of the European Economic Area. For more information see [Pitchero's privacy policy](#).

We will only keep records of your personal information for as long as is reasonably necessary for the purposes for which we have collected it, and in order to comply with any statutory or regulatory obligations in relation to retention of records. We respect requests to stop processing your personal data this includes keeping a record of your request indefinitely so that we can respect your request in future.

Your rights
